TRUSTEE RESPONSIBILITIES & DUTIES

Overall Purpose

The Board of Trustees are responsible for the overall governance and strategic direction of the charity, developing the organisation's aims, objectives and goals in accordance with the governing documents, legal and regulatory guidelines. The Board meets four times per year and some board members also sit on sub-committees for Finance and Business Development, HR/Safeguarding and Policy.

Main Responsibilities

- To ensure that the charity and its representatives function within the legal and regulatory framework of the sector and in line with the organisation's governing documents, continually striving for best practice in governance.
- To uphold the fiduciary duty invested in the position, undertaking such duties in a way that adds to public confidence and trust in the charity.
- To take appropriate professional advice in all matters where there may be material risk to the charity, or where the Trustees may be in breach of their duties. This course of action will ensure the obligation to exercise their duty of care.
- To determine the overall direction and development of the charity through good governance and clear strategic planning.

Main Duties

- Ensuring the charity complies with legislative and regulatory requirements and acts within the confines of its governing documents and in furtherance of organisational activities.
- Acting in the best interest of the charity, beneficiaries and future beneficiaries at all times.
- Promoting and developing the charity in order for it to maintain its relevance to society.
- Maintaining sound financial management of the charity's resources, ensuring expenditure is in line with the organisation's objects, and investment activities meet accepted standards and policies.

- Interviewing, appointing and monitoring the work and activities of the senior paid staff.
- Ensuring the effective and efficient administration of the charity and its resources, striving for best practice in good governance.
- Acting as a counter-signatory on charity cheques and any applications for funds, if appropriate.

Accountability

As the Board are responsible and liable for the governance and functioning of the charity, they are accountable in varying degrees to a variety of stakeholders, including: members, service users, funders, OSCR, and Companies House.

Time commitment

- Over the course of a calendar year, Trustees are expected to attend at least three out of the four board meetings.
- If they sit on any of the board's subcommittees, they will be invited to attend quarterly meetings of the relevant subcommittee/s as well. Board members would be expected to attend a minimum of 75% of meetings of any sub-committees they sign up to, in addition to the board meetings.

Chris has supported the Alliance since its inception and is currently chair of its Policy Committee. After 10 years in investment management he left to pursue his true passion - international development - and spent 17 years leading the comms and advocacy work of two of the Alliance's member organisations, SCIAF and Christian Aid Scotland. He also led Christian Aid's Private Sector Advocacy Team for 2 years, and has experience working in Nepal and India.

In addition to working at larger organisations, Chris also spent around 15 years as a trustee of a small Alliance member, allowing him to understand different ways in which the Alliance can support its diverse membership.

He is currently doing consultancy work - such as helping people and organisations to invest in ways aligned with their values (e.g. he chairs the Ethical Committee for a large asset manager), which brings him into regular contact with, and gives him insight into, private sector decision-makers and NGOs around the UK and internationally. Having been a trustee of other networks such as Stop Climate Chaos Scotland and the Trade Justice Movement, he also brings wide-ranging third sector board experience. He remains as passionate about true, equitable international development as ever.
