

2023/24 Annual Membership Survey Prize Draw

Terms and Conditions

How to enter

1. The survey will close at 5pm on 2nd February 2023; survey responses received after the stated closing date will not be accepted.
2. By submitting an entry, you are agreeing to be bound by these Terms and Conditions. If you have any questions, please contact admin@intdevalliance.scot.
3. SIDA reserves the right to refuse entry, or refuse to award the prize to anyone in breach of these terms and conditions.

Eligibility

4. The survey and prize draw are open only to members of SIDA.
5. Only one entry per member is permitted. If your organization is a member, only one representative of the organization may complete the survey.
6. In entering, you confirm that you are eligible to do so and eligible to claim any prize you may win.

The Draw

7. A winner will be chosen by random draw performed by a computer process within 14 days of the prize draw or competition ending.
8. The winner will be notified by email (using details provided at entry) within 7 days of being chosen and must provide a postal address to claim their prize. If a winner does not respond to SIDA within 14 days of being notified, then the winner's prize will be forfeited and SIDA will be entitled to select another winner in accordance with the process described above.
9. The prize will be sent to the winner within 14 days of responding to SIDA.
10. The prize is non-exchangeable, non-transferable and no cash alternative is offered. SIDA reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond SIDA's control makes it necessary to do so.
11. The decision of SIDA regarding any aspect of the prize draw or competition is final and binding and no correspondence will be entered into about it.
12. The winner's name can be obtained by sending an email to admin@intdevalliance.scot within 60 days after the date of the closing date of the prize draw or competition.
13. SIDA reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.

Limitation of liability

Insofar as is permitted by law, SIDA will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of SIDA, its agents or distributors or that of their employees. Your statutory rights are not affected.
