- 1. Policy Committee membership update/ upcoming changes
 - Alliance AGM is on 5th December, and some board members are standing down. Therefore, changes to board of trustees. With this change and staff changes within existing policy committee, new policy committee members likely to be required.
 - Group agreed that Policy committee remit may need to change as a result perhaps increasing maximum numbers to accommodate fluctuating capacity to engage.
 - Joining Policy Committee with informal PCD working group could streamline work.

- Recent inaugural meeting of Water Stewardship Alliance there is buy-in from big companies

- Watching brief on business

- PCSD keen to support

IVS

- Small, don't have much resources for policy work
- Brexit massive issue for them
- Volunteering both directions so migration policy is a watching brief, and something they want to engage in
- Charity select committee effects of Brexit on smaller charities
- New Minister bringing new angle to Brexit
- SDG 16 from next year, after Brexit

IIED

- LDC climate process
- Irish and Swedes have asked for more work on Oceans access to oceans/ coastal access
- Gender equality resource tenure access, climate and gender

Action Points

- IVS to put things onto Alliance Community regarding Brexit
- Group agrees that PCSD and SDGs should remain Alliance Priority brings everyone in
- Alliance need firm policy position on Brexit Perhaps a CPG meeting on Brexit in Summer, members to share their experiences essential
- 3. Upcoming CPGs, Ministerial meetings (PCSD and Public Perceptions), other political engagement
 - Would be good to hold CPG post-march on Brexit bringing together voices on wider effects of Brexit
 - CPG on Gender in January agreed people happy with topic
 - Parliamentary event on PCSD has more value than CPG
 - Potentially a CPG on Human Rights and business in April, followed by something on Brexit in June
 - Use report on PCSD to frame meetings later on
 - Next round of Ministerial Meetings to focus on PCSD and public Perception
 - Get CPGs to look at issues, then Ministerial buy-in could follow
 - Potential need for theory of change for getting issues onto CPG agenda who has capacity for this?
 - Global reputation of Scotland also worth looking at SG will buy in to that angle
 - Scot Gov need to get baseline data on public perceptions tie in to their own reporting on international development
